The union of state, research and sector expertise ensures that all aspects of the sector are fully taken into account.


Governance of GEVES

- 2 representatives from the Ministry of Agriculture
- 2 representatives from GNIS
- 2 staff representatives from GEVES
- The President of the CTPS

in addition to a Government Commissioner (Ministry of Research) and a State Controller.

Recognition & Accreditation

With a global and harmonised Quality Management System (QMS), GEVES is recognised officially for its activities:
