Any withdrawal of an application after the date of beginning of trial preparation, whether the variety is planted in trials or not, will be subject to a charge of 100% of the DUS fee.

The samples must be submitted without any additional cost for the GEVES (i.e. free of charge, carriage or postage paid, and free of duty). The sender is responsible for all carriage incurred, and for proper delivery of the plant material, including all the necessary phytosanitary and customs requirements and the inspection fees thereof, and all handling charges. This includes all charges raised at airports and docks "en route". All plant health documentation required by European Union regulations must be provided by the applicant.

For any additional characteristic to be observed, a quote will be issued, and the additional test will be invoiced accordingly.
